### Purpose

- To determine if a FIPS 201
   Product/Service complies with mandated requirements.
- To establish an Approved
   Product/Service List (APL) for use by agencies in the acquisition of FIPS
   201 Products/Services
- Product/Service approval process flowchart





- What is GSA's role?
  - -M05-24
    - Use of GSA Acquisition Services GSA has been designated as the "executive agent for Government-wide acquisitions of information technology" under section 5112(e) of the Clinger-Cohen Act of 1996 (40 U.S.C. § 11302(e)) for the products and services required by the Directive. GSA will report to OMB annually on the activities undertaken as an executive agent.



- What is GSA's role?
  - -M05-24
    - Requirement to use federally approved products and services To ensure government-wide interoperability, all departments and agencies must acquire products and services that are approved to be compliant with the Standard and included on the approved products list.<sup>1</sup>
    - GSA will make approved products and services available through blanket purchase agreements (BPA) .... When developing BPAs, GSA will ensure all approved suppliers provide products and services that meet all applicable federal standards and requirements.

<sup>\*</sup>A forthcoming Federal Acquisition Regulation will require the use of only approved products and services.



### What is GSA's role (cont'd)?

### -GSA letter

- GSA will replace GWAC with a Blanket Purchase Agreement (BPA) for smart card systems and related products and services under Special Item Number (SIN) 132-60 within IT Schedule 70.
- new GWAC Task Orders (T.O.) on the existing GWAC will be reviewed and approved to ensure compliance with FIPS 201



- What is a FIPS 201 Product/Service?
  - A Product/Service defined by a FIPS
     201 (& related) normative requirement
  - Card/Reader special case
    - PIV CARD & READER (PHYSICAL& LOGICAL)
       REQUIREMENTS WILL NEED TO ADHERE TO GSA
       ACQUISITION REQUIREMENTS & FIPS 201 (&
       RELATED) NORMATIVE REQUIREMENTS, IN ORDER
       TO SUPPORT INTEROPERABILITY




- What are some examples of P/S that are not bound by specific FIPS 201 requirements?
