Michaela explained that Slack channel provided by NIST includes a slightly different governance, e.g., administrator's approval, that can some delay in allowing people in gaining access to the channel.

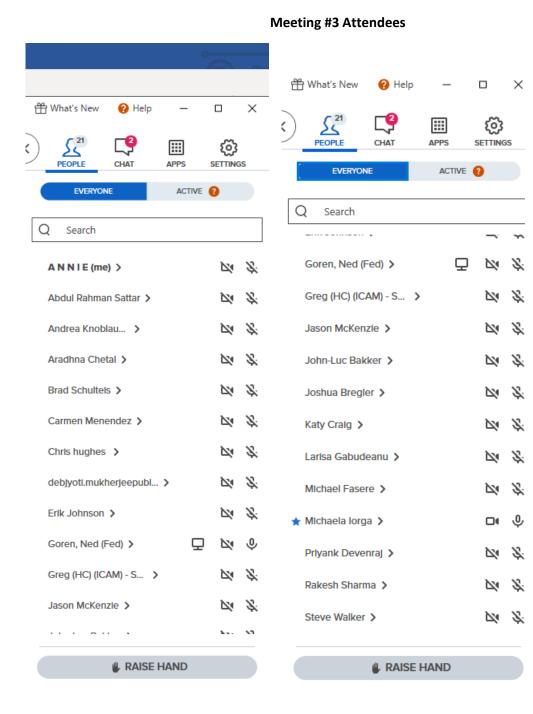
