

#### LESSONS LEARNED FROM FTC CASES









- > Don't collect personal information you don't need.
- > Hold on to information only as long as you have a legitimate business need.
- > Don't use personal information when it's not necessary.

- > Restrict access to sensitive data.
- > Limit administrative access.

Insist on complex and unique passwords.

> Store passwords securely.

- > Guard against brute force attacks.
- > Protect against authentication bypass.

#### **10** Secure paper, physical media, and devices.


- > Securely store sensitive files.

- > Dispose of sensitive data securely.


