Directions

The headquarters site of the National Institute of Standards & Technology is located near Gaithersburg, Maryland, just off Interstate Route 270, about 25 miles from the center of Washington, D.C. NIST provides shuttle service from the Shady Grove Metro station. Additional visitor information may be found at http://www.nist.gov/public_affairs/visitor.htm

Northbound Route I-270

From Washington/Virginia (northbound Rt. I-270), enter the Collector/Distributor lanes at Exit 9 and take Exit 10, Rt. 117 West, Clopper Road. Bear right at the first light onto Clopper Road/ West Diamond Avenue. Turn left at the next traffic light.

Proceed through the main gate showing your Gate Pass to the NIST police. You do not need to check in through the Visitors Registration Office. See instructions below "After Passing Through the Main Gate".

Southbound I-270

From southbound I-270 take Exit 11, Route 124, Montgomery Village Avenue/Quince Orchard Road. Bear right at the first light onto Route 124 West, Quince Orchard Road. After you merge onto Rt. 124, Quince Orchard Road, turn left at the second light onto Route 117, West Diamond Avenue. Turn right at the first light onto NIST grounds. **Proceed through the main gate showing your Gate Pass to the NIST police. You do not need to check in through the Visitors Registration Office. See instructions below "After Passing Through the Main Gate".**

Metro/NIST Shuttle

To reach NIST via Metrorail, take the Red Line to the Shady Grove end. A NIST shuttle service runs between Shady Grove metro and NIST's Administration Building at :15 and :45 minutes past the hour, beginning at 8:00 a.m. and ending at 5:30 p.m. You can board the shuttle at the East side "Kiss & Ride" bus kiosk. There will be a sign on the vehicle that identifies it as the NIST Shuttle. You must show a valid I.D. to board the shuttle. **Show your Gate Pass to the driver to be dropped off at the Administration Building.** When planning your Metro schedule, please be sure to allow sufficient time. The shuttle departs from the front of the NIST Administration Building on the hour and half hour.

After Passing Through the NIST Main Gate:

Turn left and proceed to the first four-way intersection, turn left. Visitor parking is available in the lot across from the Administration Building (11-story tower building) on your right. In the main lobby, an officer will ask to see your Gate Pass again. Proceed down the corridor with the flags and turn left to the Red Auditorium. You must present a valid ID when receiving your badge at the registration desk. Failure to present a valid photo ID will result in no admittance.
